To avoid confusion, a "party" is defined as all parties who are represented by the same counsel.

# **CANCELLATION POLICY**

A minimum fee of three hours for half-day sessions and six hours for full-day sessions will be charged. We do not charge rescheduling fees for mediations that are canceled or rescheduled prior to seven (7) days before a scheduled mediation. All cancellations must be communicated in writing (e-mail is sufficient) with the agreement of all parties noted.

Please note that for Bonavita Mediation to remain neutral, it is our policy to bill all parties equally for their portion of our minimum fees regardless of which party cancels a session or why it was canceled, even if it is being rescheduled, has settled, or one side is still willing to move forward.

# **PAYMENT**

Law firms and lawyers, not their clients, will be invoiced and are responsible for the mediation bill. Payment is due within ten (10) days of the date of the bill and is not conditioned on receipt of the settlement funds. Past due bills will accrue interest at the highest legal rate and will result in additional charges for time and fees spent on collection.

When necessary, we reserve the right to require a deposit. Failure to pay a requested deposit by the deadline will result in cancellation of the mediation.

Pro se parties must pay no later than the conclusion of the mediation conference.
